Summary

DocVelocity/AIQ logins are changing to begin to utilize multi-factor authentication (MFA). MFA is an electronic authentication method in which a user is granted access to a website or application only after successfully presenting two or more pieces of evidence to an authentication mechanism. U.S. Bank will implement MFA for all DocVelocity/AIQ users on the morning of **August 10, 2023**.

This information is intended to assist your organization in the transition to MFA for all users including specific scenarios for those organizations using single user or shared email addresses as shown below. Proactively sharing this information within your teams will be essential to the successful implementation of MFA and will assist in minimizing delays in using the application.

Action Required on August 10th

Users will be required to complete MFA when logging into AIQ for the first time beginning August 10 and later. MFA must be completed for each device and desktop/web application used to log-in to AIQ (i.e., computer, tablet, cell phone, multiple users on a shared account, etc.)

IMPORTANT: The PIN is specific to the workstation IP address and must be used by the person who requested it. If a single user ID or shared email address is utilized by multiple people to login to AIQ, setting up MFA must be coordinated by the users within your organization to ensure the correct PIN is being used for each attempt.

Reminders for Easy Set-Up

If a single user ID or shared email address is utilized by multiple people to login to AIQ, MFA authentication will require coordination to ensure the correct PIN is used for each setup attempt. The PIN is IP address specific and must be used by the person who requested it.

- If a user tries validating with an incorrect PIN, an error message will populate to try again.
 - Message will display - *The PIN you entered was incorrect. Click Re-Try to try again. To go back to the initial log in screen and try again, click Re-Validate.*
- Multiple attempts with an incorrect PIN will lock the account, and a reset will be needed.
 - Message will display - *Authentication failed: Your account is locked on account of exceeding number of permissible failed login attempts. Please contact your Site Administrator if you want to unlock your account immediately.*

A PIN must be utilized within 15 minutes of the dispatch request.

When attempting to use the PIN after 15 minutes, a message stating *You have exceeded the 15 minutes for entering the PIN. Go back to the initial log in screen and try again* will display.

Multi-Factor Authentication (MFA) for AIQ

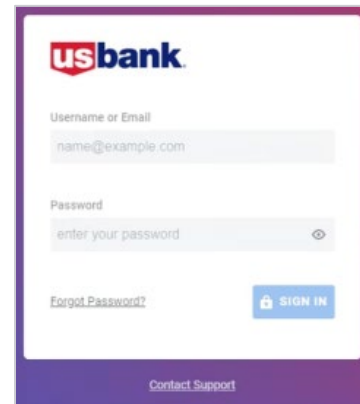
Beginning August 10, 2023, users will be required to complete Multi-Factor Authentication when logging into AIQ. MFA must be completed for each individual device and desktop/web application of AIQ used to log-in to AIQ (i.e., computer, tablet, cell phone, multiple users on a shared account, etc.). Current login/password will not change, but will need to be coordinated within your company the timing in which each employee requests access to their PIN.

IMPORTANT: The PIN is IP address specific and must be used by the person who requested it on the specific workstation they requested it from. Current login/password will not change; if a single user ID or shared email address is utilized by multiple people to login to AIQ, setting up MFA must be coordinated by all users within your organization to ensure the correct PIN is being used.

- Enter *Username* and *Password*. Click *Sign In*.

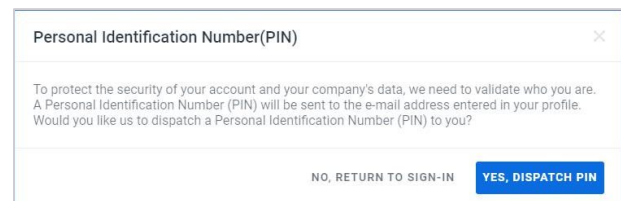


- You will be prompted to dispatch a Personal Identification Number (PIN).
 - Click *Yes, Dispatch PIN*.

The PIN is only valid for 15 minutes, once expired a new PIN will need to be requested.

- An email containing a one-time PIN will be generated and sent to the email address registered for User ID.

Reminders for Easy Set-Up

MFA must be completed for each individual device and desktop/web application of AIQ used to log-in to AIQ (i.e., computer, tablet, cell phone, multiple users on a shared account, etc.).

If a single user ID or shared email address is utilized by multiple people to login to AIQ, MFA authentication will require coordination by users of the shared login to go through this process for each device used to login to AIQ across your organization to ensure the correct PIN is used for each setup attempt. The PIN is IP address specific and must be used by the person who requested it.

- If a user tries validating with an incorrect PIN, an error message will populate for them to try again.
 - Message will display - *The PIN you entered was incorrect. Click Re-Try to try again. To go back to the initial log in screen and try again, click Re-Validate.*
- After three attempts with an incorrect PIN, the account will be locked, and a reset will be needed.
 - Message will display - *Authentication failed: Your account is locked on account of exceeding number of permissible failed login attempts. Please contact your Site Administrator if you want to unlock your account immediately.*
